



COMMONS REGISTRATION ACT 1965

In the Matter of Passfield Common,
Bramshott, East Hampshire D

DECISION

These disputes relate to the registrations at Entry Nos 1, 5, 7, 8, 14 (now 41), 17 (now 33), 19 (now 36), 21, 22 and 23 in the Rights Section of Register Unit No CL. 92 in the Register of Common Land maintained by the Hampshire County Council and are occasioned by Objection Nos OB 458 and OB 703 both made by the National Trust and respectively noted in the Register on 31 December 1970 and 4 August 1972.

I held a hearing for the purpose of inquiring into the dispute at Winchester on 5 May 1978. The hearing was attended by Mr J Trimmer of Messrs W Bradley Trimmer & Co on behalf of the National Trust and by Mr J H Ellis the applicant for Rights under Entry No 7 in person.

Mr Trimmer invited me to confirm all the said Entries other than Entry No 5 modified as hereinafter set out and as regards Entry No 7 Mr Ellis agreed. In the absence of all the claimants other than Mr Ellis I accede to Mr Trimmer's invitation and confirm all the said Entries modified as follows:-

- Entry No 1 by deleting all the words in column 4 and substituting therefor the words "A right of pannage for 2 pigs and a right of estovers"
- Entry No 7 by deleting all the words in column 4 and substituting therefor the words "A right to graze 50 geese and 2 goats and a right of estovers"
- Entry No 8 by deleting all the words in column 4 and substituting therefor the words "A right to graze 2 goats and a right of estovers"
- Entry No 14
(now 41) by deleting all the words in column 4 and substituting therefor the words "A right to graze 1 cow and 2 horses and a right of estovers"
- Entry No 17
(now 33) by deleting all the words in column 4 and substituting therefor the words "A right to graze 1 horse and 6 goats and a right of estovers"
- Entry No 19
(now 36) by deleting all the words in column 4 and substituting therefor the words "A right to graze 1 pony and a right of estovers"
- Entry No 21 by deleting all the words in column 4 and substituting therefor the words "A right of estovers"
- Entry No 22 by deleting all the words in column 4 and substituting therefor the words "A right of estovers"
- Entry No 23 by deleting all the words in column 4 and substituting therefor the words "A right to graze 1 cow and 5 ponies and a right of estovers"

In the absence of the applicant for rights under Entry No 5 to support the claim
