CORRECTION TO DECISION

After reading a letter dated 1 March 1977 from the Solicitor of the Port of London Authority, I correct my decision dated 7 February 1977 and made in this matter as follows:-

Page 2 paragraph 3 line 4:- Delete "were"

Page 7 paragraph 4 line 3:- For "1929" substitute "1949"

Page 7 paragraph 5 line 10:- At end of line for "point" substitute "points A and B"

Page 8 paragraph 6 line 1:- For "N" substitute "M"

Page 8 paragraph 6 line 6:- After words "belonging to" insert "on the north side up to the ditch to PLA and on the south side from the ditch"

Page 8 paragraph 7 line 6:- After the words "part of the Unit Land" insert "which is cross-hatched black on plan no 3 annexed to the conveyance dated 24 July 1931 and in the Schedule hereto said to have been marked MRF9 (an extract from which plan with the cross-hatched part thereon marked by me with the letters P P P P P is hereunto annexed), being the part"

Page 8 paragraph 7 line 11:- For "the Dyke" substitute "the western of the two dykes"

Page 8 paragraph 7 line 12:- Delete "and" on the first occasion that it appears and after "Unit Land" insert "between the points M and N on the Decision Plan and"

Page 8 paragraph 7 line 13:- After "OS 7200" insert "and 6867"

Page 8 paragraph 7 line 14:- For "map" substitute "map; and (5) the north part (to the ditch) of such part of the Unit Land if any as lies between the ~~points~~ ^{points} B and M on the Decision Plan."

Page 9 line 5:- Delete "and" on the second occasion that it appears

Page 9 line 7:- For "map." substitute "map; (5) the south part (to the ditch) of such part of the Unit Land if any as lies between the points B and M on the Decision Plan"



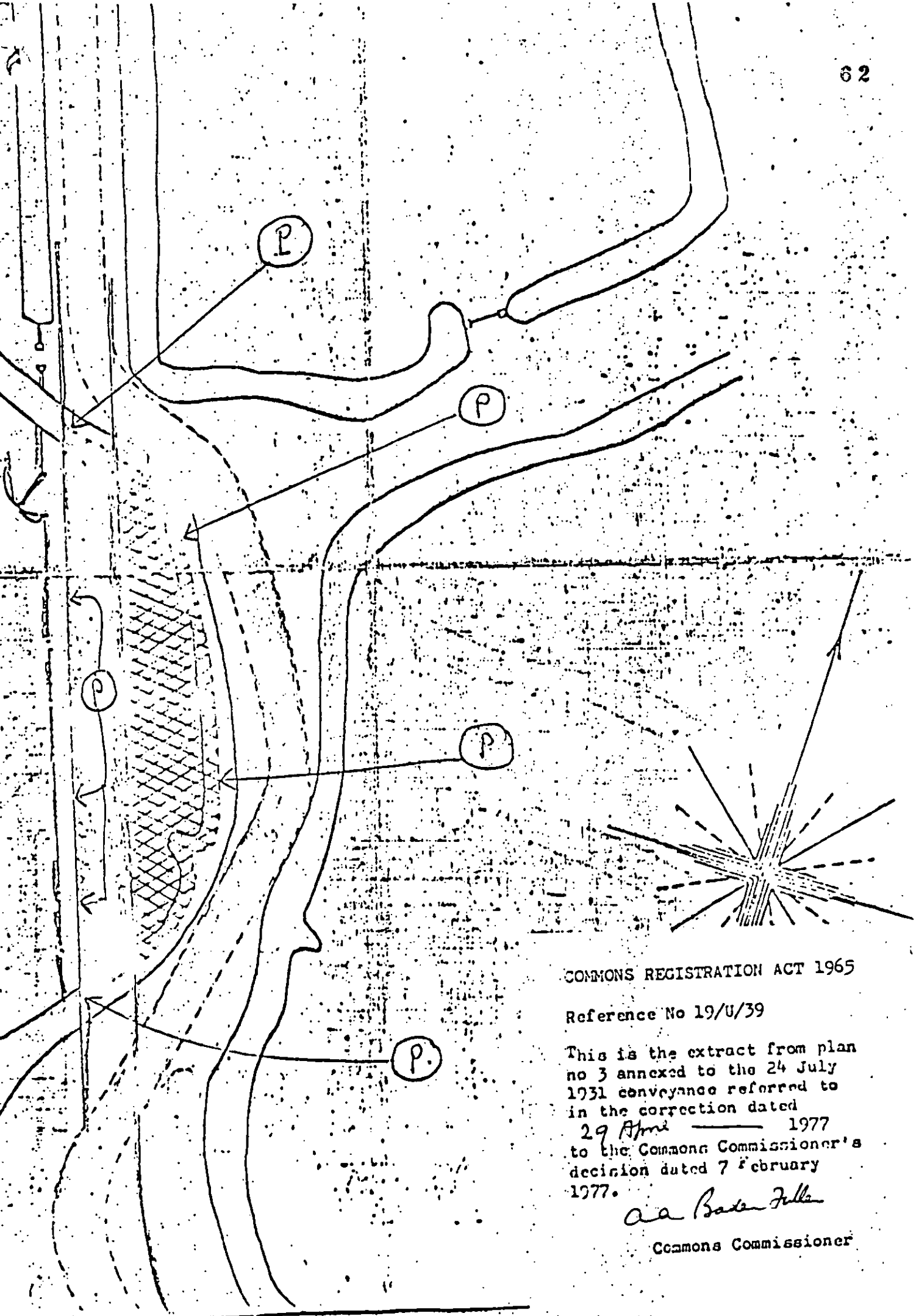
Page 9 line 13:- Add at the end of the paragraph: "In this paragraph the point B in relation to land north or east of Mead Wall means the northwest corner of OS No 5874 and in relation to land south or west of Mead Wall means the point where Mead Wall is met by the north-south dyke which is nearest to the point marked B on the Decision Plan, and which is on the Register map marked "Drain".
