

COMMONS REGISTRATION ACT 1965

Reference Nos 276/D/65 to 73

In the "atter of Carneddau Hill, Llansaintffraid-in-Elvel, Llanfarredd and Disserth and Trecoed, Radnor D

## DECISION

These disputes relate to the registration at Entry nos 1, 2, 3, 13, 15, 21 and 22 in the Rights Section of Register Unit No CL. 7 in the Register of Common Land maintained by the former Radnorshire County Council and is occasioned by the Objections set out in the Schedule to this decision.

I held a hearing for the purpose of inquiring into the dispute at Llandrindod Wells on 26 May 1977. The hearing was attended by Mrs Goffrey the applicants for rights under Entry No 22.

By a letter dated 16 May 1977 addressed to the Clerk of the Commons Commissioners the Honourable Mrs  $\Xi$  S J Legge-Bourke withdrew all the Objections other than Objection No 324 and I therefore confirm all the above mentioned Entries other than Entry No 22.

Wr % Mrs Goffrey claimed the right to graze 2 horses and rights of estovers, turbary and piscary as appurtenant to a private dwelling house with a small garden. They had no documentary evidence to support their claim and no knowledge of the exercise of any of the rights claimed by them. In these circumstances I have no alternative but to refuse to confirm the Entry No 32.

Mr & Mrs Goffreys major concern was to have a right of way as a means of access to their private dwelling loose over the cummon, and they will no doubt seek to have this claim noted in the Register.

I am required by regulation 30(1) of the Commons Commissioners Regulations 1971 to explain that a person aggrieved by this decision as being erroneous in point of  $\frac{1}{1}$  may, within 5 weeks from the date in which notice of the decision is sent to  $\frac{1}{1}$  min, require me to state a case for the Jecision of the High Court.
