

COMMONS REGISTRATION ACT 1965

Reference No 231/U/43

In the Matter of Llanvair Hill, Llanfair Waterdine, South Shropshire District, Salop

DECISION

This reference relates to the question of the ownership of land known as Llanvair Hill, Llanfair Waterdine, South Shropshire District being the land comprised in the Land Section of Register Unit No VG. 26 in the Register of Town or Village Greens maintained by the Salop County Council of which no person is registered under section 4 of the Commons Registration Act 1965 as the owner.

Following upon the public notice of this reference no person claimed to be the freehold owner of the land in question and no person claimed to have information as to its ownership.

I held a hearing for the purpose of inquiring into the question of the ownership of the land at Shrewsbury on 22 June 1978. At the hearing (1) Mr A F Beavan (2) Mrs K M Jones and (3) Mr T S F Jones were represented by Mr P J Medlicott solicitor of G. M Medlicott & Son, Solicitors of Knighton.

The land ("the Unit Land") in this Register Unit (according to the Register) contains about 10 acres, is approximately square, and is divided by Offas Dyke (here on a nearly north-south line) and a track (either adjoining or very near to the Dyke).

Mr Medlicott in the course of his evidence produced the documents specified in the Schedule hereto, from which I conclude that Mr Beavan is the owner of the land to the east of the track (according to his conveyance about 5.097 acres) and Mrs & Mr Jones are the owners of the land to the west of the track (according to their conveyance about 4.922 acres).

As to the track, Mr T S F Jones said that it is a green road not tarmacadamed, over which there is or may be a public right of way for vehicles. It is shown on the OS map 1/50,000, Sheet 137 as "Road used as a public path or highway open to all traffic". Whatever may be the exact status of the track, I consider that I should in accordance with the general law treat the conveyances as passing the ownership of the track up to its middle line.

For the above reasons, I am satisfied that Mr Beavan and Mrs & Mr Jones are the owners of the Unit Land, and I shall accordingly in pursuance of section 8(2) of the 1965 Act direct Salop County Council as registration authority (1) to register Mr Alfred Francis Beavan of The Craig, Illanfair-Waterdine as the owner of the part of the land which is east of the track marked on the Register map as running across the land on an approximately north-south line, which contains a little more than 5 acres and which is bounded on the west by the middle line of the said track; and (2) to register Mrs Kathleen Mary Jones and Mr Thomas Stephen Frederick Jones both of Illanfair Hall, Illanfair-Waterdine as the owners of the part of the said land which is west of the said track, which contains a little less than 5 acres and which is bounded on the east by the said middle line.



I am required by regulation 30(1) of the Commons Commissioners Regulations 1971 to explain that a person aggrieved by this decision as being erroneous in point of law may, within 6 weeks from the date on which notice of the decision is sent to him, require me to state a case for the decision of the High Court.
