I held hearings to inquire into these disputes at Swansea on 15, 16 and 17 July 1997 and 12 and 13 November 1997.

The hearings were attended by the following (not all of whom were present after the first day):

Mr J B Humphreys of the City and Council of Swansea (the Registration Authority)
Mr Leslie Richards, Solicitor, representing the Gower Commoners Association



Mr John Ellis, the Chairman of the Gower Commoners Association

Mr Gavin Hogg, land agent, representing The National Trust

Mr Morris and Mr Gabe representing The Trustees of the Somerset Trust and

Mr and Mrs D.R. Bennett and others.

By far the greater part of the references dealt with in this Decision are conflicts between two Rights entries as to the land to which the Rights are respectively claimed to be attached. Mr Jack Ellis as Chairman of the Gower Commoners Association had prior to the hearings worked hard to resolve these conflicts. In consequence Mr Humphreys was able to tell me at the first hearing that nearly all the conflicts could be dealt with by me on the basis of consent and do not require any finding by me beyond a record of the result. Other references I adjourned on the basis that agreement between those interested was expected and I am told by Mr Humphreys that with few exceptions (mentioned below) this has proved to be the case.

In addition to the conflicts between Rights entries mentioned above the references before me raise the following matters:

(a) Reference 828. This relates to an objection by the National Trust to the registration of the part of CL 5 edged in orange on the plan attached to the objection (number 122). I am informed that following agreement with the Commoners Association, the National Trust has withdrawn this objection and I will therefore confirm the registration of the land and of the National Trust as its owner.

(b) Reference 829. This relates to an objection by the Glamorgan County Naturalists Trust to the registration of the part of CL 5 edged in pink on Plan B attached to the Objection (Number 110). I am informed that following agreement between the Commoners Association and the Trust I should confirm the registration with the exception of fields 75B and 92. I will accordingly order the removal of these two fields but otherwise confirm the registration.

(c) Reference 832. This relates to an objection by the National Trust to the registration of various entries in the Rights section of CL 5. The National Trust having as part of the agreement referred to in paragraph (a) above withdrawn its objection I will confirm this registration.

(d) Reference 833. This relates to an objection by the Glamorgan County Naturalists Trust to the registration of the entries last mentioned in the Rights section of CL5. The Trust having as part of the agreement referred to in paragraph (b) above withdrawn its objection I will confirm this registration.

(e) Reference 933. This relates to a conflict occasioned by registration of the same land in the Land sections of units CL 6 and VG 8. At the hearing in November 1997 I was informed that the land was in 1968 registered as Village Green by the Llanrhidian Lower Parish Council although it had previously, in 1967, been registered by the Gower Commoners Association as common land being part of unit CL 6. I was informed by Mr L Richards prior to the July hearing that he had been notified by the Clerk to the Llanrhidian Lower Common Council (successor to the Parish Council) that it did not wish to contend that the land is village green: and the Council was not



represented at the hearing. I will accordingly order the removal of the land from VG 8 and confirm its registration in CL 6.

(f) References 934 and 935. These relate to objections by Joan Ellis (of Werganrows Farm, Fairwood, Killay, Swansea) to the entries numbered 19 and 53 in the Rights section of unit CL 6. Both objections were withdrawn prior to the hearings by me.

(g) References 971 and 976. These relate to objections by Eleanor Annie Hughes (of Llanmorlais Farm, Llanmorlais, Swansea) to the entry numbered 1 in the Land Section and to the entries in the Rights section of unit CL 7. These objections were withdrawn by letter from Mrs Hughes to the Commons Commissioners dated 15 July 1997.

(h) References 972, 973, 974 and 975. These relate to conflicts occasioned by what I was informed at the hearing by Mr Humphreys and Mr Ellis were the erroneous registrations in the Land Section of CL 7 of parts of fields at Llanrhidian namely 1243, 1260, 306 and 1243. There having been no representations to the contrary (at the hearings or otherwise) I shall order the removal of these part fields from the land section and confirm their registration in the Rights section of CL 7.

(i) References 989 and 990. These relate to a conflict in the Ownership section of CL 7 occasioned by the registration of two different parties (namely the Trustees of the Somerset Trust and Christopher P.M. Methuen-Campbell) as owners of the same land comprised in this registration unit. I am informed that the matter has been resolved by agreement to the effect that both registrations shall be confirmed save that Column 4 of Entry No 1 shall read 'Cefn Bychan Common (or such part thereof as is included in this registration unit)' and Column 4 of Entry No 2 shall read 'The whole of the land in this register unit except Cefn Bychan Common and the land lying adjacent to and east of the line H - I' and I shall order accordingly.


I shall accordingly confirm, confirm with modifications and refuse to confirm the various entries in the Land Rights and Ownership Sections of the Registers in respect of Register Units CL 5, CL 6, CL 7 and VG 8 in accordance with the specific decisions given above and the resolution of the conflicting entries in the Rights sections of the Registers recorded in the schedules annexed hereto.

This is a complicated Decision which may well contain some errors or omissions. I propose therefore to allow any interested person a period of 6 weeks from the date on which this Decision is sent to him in which to write in to the Commons Commissioners drawing attention to any error or omission or other matter of any description which I may have disregarded, misunderstood or overlooked. If as a result of such correspondence any matters are raised which I consider relevant and which cannot be disposed of by agreement I will hold a further hearing to resolve the issues which arise.

I am required by regulation 30(1) of this Commons Commissioners Regulations 1971 to explain that a person aggrieved by this Decision as being erroneous in point of law

may within 6 weeks from the date on which notice of this Decision is sent to him, require me to state a case for the decision of the High Court.


