SECOND DECISION

This is supplemental to a decision dated 2 November 1983 and made by me in the above Matter relating to registrations in the Rights Section and the Ownership Section of Register Unit No. CL 73 in the Register of Common Land maintained by Devon County Council.

I have a letter dated 25 November 1983 and written on behalf of the Belstone Commoners Association applying for an amendment of my said decision in respect of Rights Section Entry No. 129 made on the application of Mr John Frederick Young and Mrs Rosina Ivy Young of rights of common attached to Ford Farm, Sticklepath, South Tawton.

By my said decision (the antepenultimate paragraph on page 9) I gave liberty to apply to correct clerical errors. By regulation 33 of the Commons Commissioners Regulations 1971, I have power to correct any clerical mistake or error arising from any accidental slip or omission. My omission from paragraph 2 of the Second Schedule to my said decision of "129 (J F and R I Young)" was accidental, and the inclusion of "129 (J F and R I Young)" in paragraph 7 of the said Schedule arose from this omission. Accordingly I have this day corrected my said decision as set out in the First Schedule hereto.

The Belstone Commons Association have also pointed the clerical errors set out in the Second Schedule hereto. I regret these errors. But it does not I think follow that I should about them formally correct my said decision; a correction by me would involve the County Council as registration authority and other persons who have received copies of my said decision in trouble and possibly expense, which I should avoid in the absence of some good reason. Notwithstanding these errors, my said decision as it now stands is unambiguous as regards the persons who I have erroneously misdescribed, and I shall therefore not correct my said decision. I apologise to the individuals concerned, and hope that those who have received copies of my said decision will note on it the errors listed in the Second Schedule hereto.

I am required by regulation 30(1) of the Commons Commissioners Regulations 1971 to explain that a person aggrieved by this decision as being erroneous in point of law may, within 6 weeks from the date on which notice of the decision is sent to him, require me to state a case for the decision of the High Court.
