DECISION

This dispute relates to the registration at Entry No 1 in the Land Section of Register Unit No VG. 125 in the Register of Town or Village Greens maintained by the Gloucestershire County Council and is occasioned by Objection No OB 474 made by Gloucestershire County Council and noted in the Register on 23 October 1972.

I held a hearing for the purpose of inquiring into the dispute at Gloucester on 15 October 1976. The hearing was attended by Mr Limbrick, senior legal executive, on behalf of Gloucestershire County Council and Mr H W Kirkwood a member of the Bisley with Lypiatt Parish Council.

Mr Limbrick claimed that the land coloured blue on the plan<sup>A</sup> annexed to this decision forms part of the County Highways and Mr Kirkwood did not dispute this claim.

Mr Limbrick raised no objection to my confirming the registration modified so as to exclude the said land coloured blue, and I therefore confirm the registration modified as aforesaid.

I am required by regulation 30(1) of the Commons Commissioners Regulations 1971 to explain that a person aggrieved by this decision as being erroneous in point of law may, within 6 weeks from the date on which notice of the decision is sent to him, require me to state a case for the decision of the High Court.

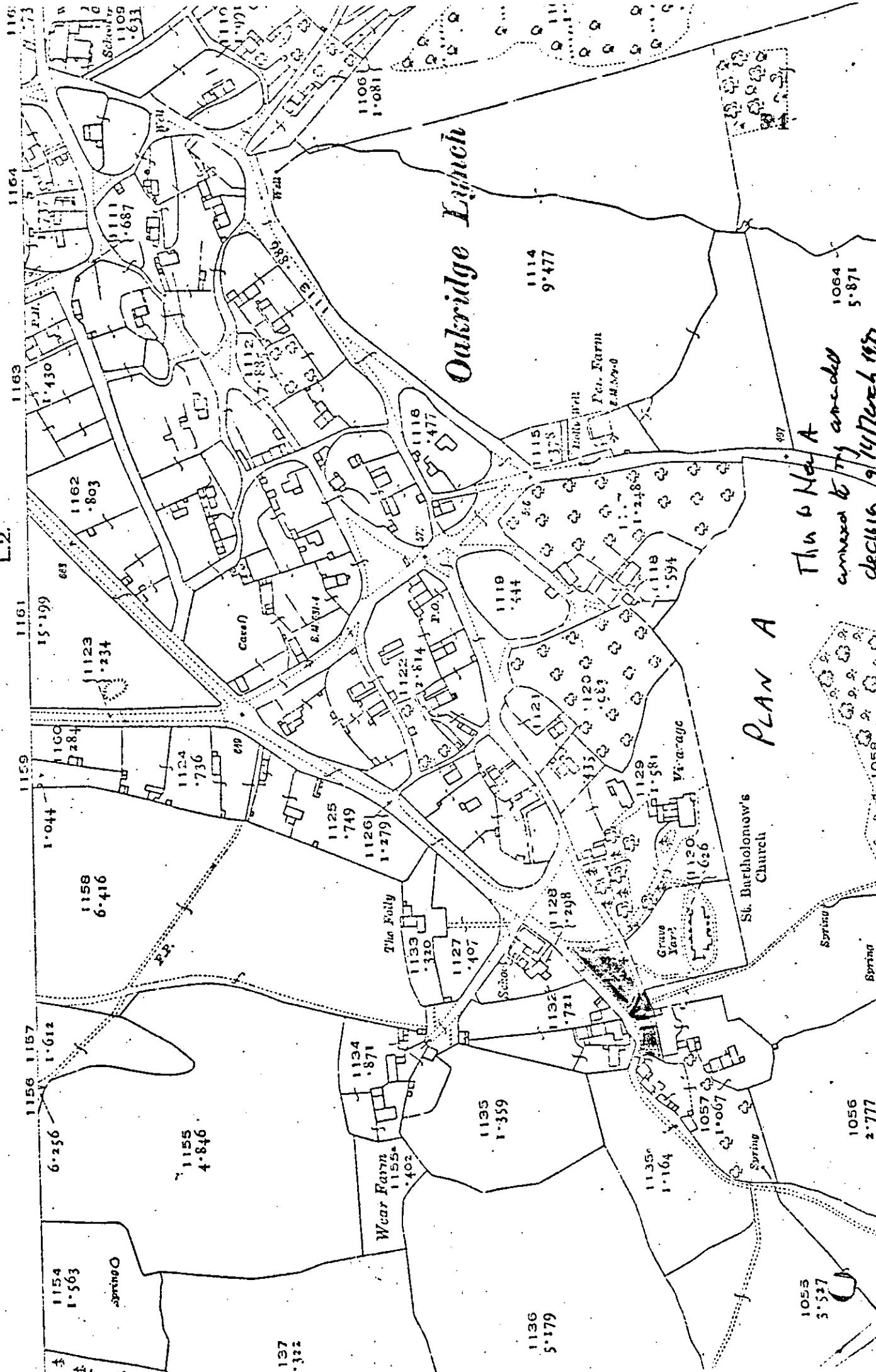
