FIRST SCHEDULE

Part I: definitions

In this decision save where the context otherwise requires:-

- (1) "CL97 land" means the land comprised in the Land Section of Register Unit No CL97, as such registration was constituted on 4 October 1968.
- (2) "CL124 land" means the land comprised in the Land Section of Register Unit No CL124 as such registration was constituted or purported to have been constituted on 6 October 1969.
- (3) "Golf Links" means the part of the CL97 land between the railway and the foreshore.
- (4) "OS3430" means the part of the CL97 land so numbered on the OS map, 1/2500 1901 edition, and thereon marked as containing 7.764 acres, being when the map was made between the railway and the road (as thereon marked) between Aberdovey and Tywyn, and now situated south-west of the buildings and land held therewith known as Trefeddian Hotel and Trefeddian Terrace and now in places crossed by the A493 road.
- (5) "Recreation Ground" means the part of the CL97 land between the railway and the A493 road exclusive of OS3430.
- (6) "Morfa Gypsies" means the part of the CL97 land north of the A493 road exclusive of any of OS3430 now north of such road but including the Cliff Area next mentioned.
- (7) "Cliff Area" means the part of Morfa Gypsies which is within the CL97 land, which is narrow (too small to appear on the Principal Decision Plan), which extends eastwards for about 100 yards from the west end of Morfa Gypsies and which is not part of the CL124 land.
- (8) "Aberdyfi Village Area" means the part of the CL124 land which is not within the CL97 land which extends eastwards from the Golf Links for about $\frac{1}{2}$ a mile so as to include land south of Bodfor Terrace and Glan Dovey Terrace and which ends near the centre of the village.
- (9) "2653 Area" means the part of the CL124 land which is not within the CL97 land, which is bounded on the west by the north-east part of the east boundary of the CL97 land, which is part of the land numbered 2653 on the said OS map and thereon marked as containing 11.383 acres, and which is part of the land darkly shaded on the plan annexed to Objection No 437 made by Meureg Rees. The 2653 Area with OS No. 2651 containing 8.494 acres is between the CL97 land and the railway. The 2653 Area with the PQR Area next defined together comprise the whole of OS 2653 and the whole or most of the land darkly shaded on the plan annexed to Objection No. 437.

(10) "PQR Area" means the part of OS 2653 approximately triangular with sides of about 100 yards long from north to south and has an average width of about 15 yards which comprises the remainder of OS 2653 and all or most of the remainder of, the land darkly shaded on the plan annexed to Objection No. 437, and all is within the CL97 land.

(11) "XYZ Area" means the part of the CL124 land which is not within the CL97 land, which is about 100 yards long from east to west and about 50 yards wide and which is west of and adjoins the Recreation Ground.

(12) "ABC Area" means the part of the CL124 land which is not within the CL97 land, which is between the Recreation Ground and the land held with the Railway Station (too irregular and small to appear on the Principal Decision Plan), and which includes the footpath or track marked with a green line on the plan enclosed with CL124 Objection No. 465 (being the line PQRS on the BR Plan).

(13) "Highway Improvement Area" means the three areas marked "10", "4" and "Deed of dedication 17 March 1969" on the plan (County/3) extracted on the Highway Improvement Plan.

(14) "Fire Station Area" means the area coloured red on the plan (County/4) extracted in the Fire Station and Car Park Plan.

(15) "Car Park Area" means the area edged green on the said plan (County/4) extracted on the Fire Station and Car Park Plan.

(16) "Play Area" means the land edged red on the plan attached to the 1979 conveyance (MDC/3) extracted on the Play Area Plan.

Part II: CL97: existing registrations

(A) Land Section:-

Entry No. 1:- Made on application dated 25 June 1968 of Llewelyn Williams, Clerk of the Urban District Council, Tywyn. Land within application shown coloured green on plan therewith.

Noted on Register: application dated 20 June 1968 by Ellis Williams for registration of Gypsy Morfa otherwise known as Morfa Gypsy. Land within this application "edged Green" on plan annexed, being the part of the UDC application land north of the A493 road Morfa Gypsies) except comparatively very narrow and short area ("the Cliff Area").

(B) Rights Section: Entry Nos

- (1) Isobella Mary Alison Rieben: owner: Penhelig Uchaf: graze winter 20 sheep, summer 5 cattle: over the CL97 land.
- (2) Meuric Rees: owner: Dyffrynglyncul: graze 28 sheep and 7 cattle: over the CL97 land.
- (3) David John Roberts: owner: Treffeddian: graze 28 sheep and 7 cattle: over the CL97 land.
- (4) John Alfred Owen: owner: Pwllhelig: graze 4 cattle or 16 sheep or sheep and cattle to 16 stints (1 cattle = 4 stints, and 1 sheep = 1 stint): over the CL97 land.
- (5) Urban District Council of Tywyn: owner: part of Tynewydd Farm: graze winter 16 sheep and summer 4 cattle: over the CL97 land.
- (6) Frederick Webber Davies: owner: Bwlchgwyn: graze 4 cattle or 16 sheep or sheep and cattle to a limit of 16 stints (1 cattle = etc as above): over the CL97 land.

(C) Ownership Section (as amended in 1972): Entry Nos :-

- (1) The Urban District of Tywyn: of — (a) tract known as Morfa Gypsies lying north of the A493 road (OS No. 3481): and (b) tract known as the Recreation Ground lying south of the A493 road, OS No. 3480.
- (2) The Aberdovey Golf Club, by its Trustees being:- (i) Norman John Cave-Brown-Cave, (ii) Selwyn Wooton Hill, and (iii) Thomas Evan Jenkins: of all the CL97 land being parts of the Warren and Aberdovey Marsh and Foreshore down to high water mark except parts as described in Entry No. 1 (as above).

(D) Objections, all → by the Trustees, Aberdovey Golf Club:-

No. 181: to Rights Entry No. 1: (a) correct right to graze sheep should be for the number of 10, not 20 as claimed; (b) right to graze on OS 3430 has been lost by non-usage.

No. 182: to Rights Section Entry No. 2: (a) → correct grazing rights are for cattle or sheep, not cattle and sheep as claimed; (b) cattle are to be grazed only in the summer months and sheep in the winter months; (c) correct right to graze sheep would be for the number of 14 not 28 as claimed; (d) as for No. 181(d).

No. 183: to Rights Section Entry No. 3: the same as No. 182 above.

No. 184: to Rights Section No. 4: (a), (b) and (d), same as No. 182(a), (b) and (d) above, (c) correct right to graze sheep should be for the number of 8, not 16 as claimed.

No. 185: to Rights Section Entry No. 5: (a) the whole farm of Tynewydd has been divided between different owners, so that the claimant must state what proportion of the original dominant tenement is now owned by him, in order that the claimant's proportion of the total rights pertaining to this tenement may be properly quantified; (b) of the proportion of the farm Tynewydd now owned by the claimant a part has been built on, so that the common rights should be abated proportionately; (c) the grazing right for sheep should be twice the number of cattle grazed not four times as claimed; (d) same as No. 181(b) above.

No. 186: to Rights Section Entry No. 6: (a), (b), (c), (d), same as No. 184(a), (b), (c), (d) above.

Part III: CL124, existing registrations

Land Section Entry No. 1:-

Made in consequence of application dated 25 August 1969 by Evan Pugh Jones and Thomas John Jones, therein land said to be coloured red on plan marked "C".

Note: No copy of such plan produced, but assumed CL 124 Register map based on it.

(B) Rights Section Entry Nos:-

(1) Evans Pugh Jones and Thomas John Jones: owners: Tyddyn-Rhys-y-Gadair and Tynewydd: graze 10 cattle and 40 sheep: over the CL124 land.

(2) Lewis Griffith Jones: owners: Tyddyn-y-Berth: graze 6 cattle and 24 sheep; over the CL124 land.

(3) Evan Edfryn Davies: owner: Erwpistyll: 4 cattle or 16 sheep or sheep and cattle to a limit of 16 stints (1 cattle = ... as in CL97 (4) above): over the CL124 land.

(4) Evan Edfryn Davies: tenant: Penhelig Ucha: graze 5 cattle or 20 sheep or sheep and cattle to a limit of 20 stints (1 cattle = ... as in CL97(4) above): over the CL124 land.

(5) Thomas Alun Jones: owner: Erw: herbage for 3 cattle or 12 sheep: over the CL124 land.

(6) Thomas David Jones: Thomas Alun Jones and David Henry Jones: owners: Crychnant: herbage for 10 cattle or 40 sheep: over the CL124 land.

Ownership Section (as amended in 1972):-

Entry No. 3: Aberdovey Golf Club, by its Trustees (i) Norman John Cave-Brown-Cave, (ii) Selwyn Wooton Hill and (iii) Thomas Evan Jenkins: of land being parts of the Warren and Aberdovey Marsh and Foreshore down to HWM being OS No. 2256, 2654, 3430 and part 3513; on Register Map shown by a dotted red line.

(1) Land Section Objections:-

No. 437: by Meuric Rees: the land was not Common Land at the time of registration and does not form part of the adjoining common; Plan attached shows triangular area darkly shaded being the 2653 Area as in this decision defined together with comparatively small addition at its south end.

No. 465: by T D Cook, District Estate Surveyor, Rail House, Broad Street, Birmingham; part of the land registered as Common Land is in the freehold possession of the British Railways Board and used for operational railway purposes: plan enclosed shows green line and edged and hatched purple (PQRT on the BR Plan).

Rights Section Objections all by Trustees, Aberdovey Golf Club:-

No. 187; to Rights Section Entry No. 1:

- (a) the farms Tyddyn-rhys-y-gadair and Tynewydd are separate dominant tenements with separate quotas of grazing rights and the claimants should state the separate rights they claim for each farm or that portion thereof they now own.
- (b) a portion of the original dominant tenement of Tyddyn-rhys-y-gadair has been sold for building land, so that the former quota of common rights applicable to the whole area must be abated proportionately for that part remaining as farm land.
- (c) the numbers of animals for which rights are claimed are excessive because of the above.
- (d) the correct grazing rights are for cattle or sheep, not cattle and sheep as claimed.
- (e) cattle are to be grazed only in the summer months and sheep in the winter months.
- (f) the right to graze animals on lot OS 3430 of the Common has been lost by non-usage.

No. 188; the Rights Section Entry No. 2:

- (a) the correct grazing rights are for cattle or sheep, not cattle and sheep as claimed.
- (b) cattle are to be grazed only in the summer months and sheep in the winter months.
- (c) the correct right to graze sheep should be for the number of 12, not 24 as claimed.
- (d) the right to graze animals on lot OS 3430 of the common has been lost by non-usage.

No. 189; to Rights Section Entry No. 3: (a), (b) and (d) same as 188(a), (b) and (d) above; (c) the correct right to graze sheep should be for the number of 8 not 16 as claimed.

No. 190; to Rights Section Entry No. 4; the claim for the grazing rights pertaining to the farm Penhelig Ucha has already been registered by the owner under CL97.1., so that this claim by the tenant is unnecessary and invalid.

No. 191; to Rights Section Entry No. 5; (a) and (c) the same as 188(b) and (d) above; (b) correct right of herbage for sheep should be for the number of 6, not 12 as claimed.

No. 192; to Rights Section Entry No. 6:

(a) in respect of the farm Crychnant only, the correct right of herbage for cattle should be for the number of 7, not 10 as claimed.

(b) in respect of the farm Crychnant only, the correct right of herbage for sheep should be for the number of 14, not 40 as claimed.

(c) cattle are to be grazed only in the summer months and sheep in the winter months.

(d) if claimants intended their claim to include rights which may pertain to that portion of the original dominant tenement of Tynewydd farm acquired by them they have not so stated, and they should have made a separate claim in respect of their portion of Tynewydd.

(e) the right of herbage for animals over lot OS 3430 of the common has been lost by non-usage.

(B) Deemed Objections:-

CL124 Land Section Entry No. 1 and CL97 Land Section Entry No. 1 are conflicting.

Witnessed: (1) Scheme not modified; (2) if deed ceases by effluxion of time or is determined rights of Owners and Commoners shall remain unaffected; (3) Commoners shall not ride any horse on part of land marked brown; (4) Owners during summer 1 April to 30 September allow from farms named in

THIRD SCHEDULE
(Decision table)

Part I: Consolidation

1. The confirmation of the registration in Parts II and III of this Schedule said to be confirmed shall be with the MODIFICATIONS (in addition to any modification in either such Part said to be applicable to it) set out in paragraphs 2, 3 and 4 of this Part.
2. The registrations shall be treated as having been made in a register unit numbered CL97/124, so that henceforth the Register Unit formerly numbered CL97 and the Register Unit formerly numbered CL124 will be consolidated into one Register Unit.
3. The registration at CL97 Land Section Entry No. 1 shall in the CL97/124 Land Section be numbered 1. The registration at CL124 Land Section Entry No. 1 shall in the CL97/124 Land Section be numbered 2.
4. The registrations at CL97 Rights Section Entry Numbers 1, 2, 3, 4, 5 and 6 shall in the CL97/124 Rights Section be numbered 1, 2, 3, 4, 5 and 6 respectively. The registrations of CL124 Rights Section Entry Numbers 1, 2, 3, 4, 5 and 6 shall in the CL97/124 Rights Section be numbered 7, 8, 9, 10, 11 and 12 respectively.

Note: CL97/124 Entry No. 10 (formerly CL124 Entry Number 4) will become void because confirmation of it is refused.

Part II: Land Section

1. I CONFIRM the registration at CL97/125 Entry No. 1 (formerly CL97 Entry No. 1) with the MODIFICATION that there be removed from the Register all the lands which are described in paragraph 3 of this Part and which were or may have been within this registration.
2. I CONFIRM the registration at CL97/125 Entry No. 2 (formerly CL125 Entry No. 1) with the MODIFICATION that there be removed from this Entry No. 2 all the land within the said Entry No. 1 mentioned in paragraph 1 above, and the further MODIFICATION that there be removed from the Register all the lands described in paragraph 3 of this Part which were or may have been within this registration.
3. The lands which are to be removed from the Register are: the XYZ Area, the ABC Area, the Highway Improvement Area, the Fire Station Area, the Car Park Area and the Play Area as defined in Part I of the First Schedule hereto.



Part III: Rights Section

1. I REFUSE to confirm the CL97/124 Rights Section Entry No. 10 (formerly CL124 Rights Section Entry No. 4, Evan Edfryn Davies; Penhelig Uchaf).
2. I CONFIRM the registration at CL97/124 Entry No. 1 (formerly CL97 No. 1; Isobella Mary Alison Rieben; Penhelig Uchaf) with the MODIFICATIONS; in column 2 add:-

 in column 3 add:-
 "Evan Edfryn Davies, Erwpistyll, Aberdovey, Merioneth, Tenant"
 and for all in column 4 substitute:-
 "The right to graze during the months of winter (meaning from 1 November to 30 April in each year) 20 sheep and ~~—————~~ during the months of summer (meaning from 1 May to 31 October in each year) 5 cattle over the land comprised in this CL97/124 register unit except OS No. 3430 as in this Rights Section defined."
3. I CONFIRM the registration at CL97/124 Entry No. 2 (formerly CL97 No. 2; Meuric Rees; Dyffrynglyncul) with the MODIFICATIONS: for all in column 4 substitute:-
 "The right to graze during the months of winter (meaning from 1 November to 30 April in each year) 28 sheep and ~~—————~~ during the months of summer (meaning from 1 May to 31 October in each year) 7 cattle over the land comprised in this CL97/124 register unit except OS No. 3430 as in this Rights Section defined and so that if Meuric Rees under section 8 of the 1965 Act successfully claims to be the owner of the 2653 Area specified in column 5, the said right shall be a quasi-right of common over such Area"
 and in column 5 add at the end:-
 "except the 2653 Area as in this Rights Section defined".
4. I CONFIRM the registration at CL97/124 Entry No. 3 (formerly CL97 No. 3; David John Roberts; Treffedian) with the MODIFICATION: for all in column 4 substitute:-
 "The right to graze during the months of winter (meaning from 1 November to 30 April in each year) 28 sheep and during the months of summer (meaning from 1 May to 31 October in each year) 7 cattle over the land comprised in the Land Section of Register Unit No. CL97 as such registration was constituted on 4 October 1968 except OS 3430 as in this Rights Section defined".
5. I CONFIRM the registration at CL97/124 Entry No. 4 (formerly CL97 No. 4; John Alfred Owen; Pwllhelig) with the MODIFICATION: for all in column 4 substitute:-
 "The right to graze during the months of winter (meaning from 1 November to 30 April in each year) 16 sheep and during the months of summer (meaning from 1 May to 31 October in each year) 4 cattle over the land comprised in the Land Section of Register Unit No. CL97 as such registration was constituted on 4 October 1968 except OS 3430 as in this Rights Section defined".
6. I CONFIRM the registration at CL97/124 Entry No. 5 (formerly CL97 No. 5; Urban District Council of Tywyn; Tynewydd) with the MODIFICATION: for all in column 4 substitute:-
 "The right to graze during the months of winter (meaning from 1 November to 30 April in each year) 16 sheep and during the months of summer (meaning from 1 May to 31 October in each year) 4 cattle over the land comprised in the Land Section of Register Unit No. CL97 as such registration was constituted on 4 October 1968 except OS 3430 as in this Rights Section defined".



7. I CONFIRM the registration at CL97/124 Entry No. 6 (formerly CL97 No. 6: Frederick Webber Davies; Bwlchgwyn) with the MODIFICATION: for all in column 4 substitute:-

"The right to graze during the months of winter (meaning from 1 November to 30 April in each year) 16 sheep and during the months of summer (meaning from 1 May to 31 October in each year) 4 cattle over the land comprised in the Land Section of Register Unit No. CL97 as such registration was constituted on 4 October 1968 except OS 3430 as in this Rights Section defined".

8. I CONFIRM the registration at CL97/124 Entry No. 7 (formerly CL124 No. 1; Evan Pugh Jones and Thomas John Jones, Tyddyn-Rhys-y-Gadair and Tynewydd) with the MODIFICATIONS for all in column 4 substitute:-

"The right to graze during the months of winter (meaning from 1 November to 30 April in each year) 20 sheep and during the months of summer (meaning from 1 May to 31 October in each year) 5 cattle over the land comprised in this CL97/124 register unit except OS No. 3430 as in this Rights Section defined"

and for all in column 5 substitute:-

"That farm and land known as Tyddyn-Rhys-y-Gadair in the Urban District of Tywyn in the County of Merioneth which property is more particularly delineated for identification purposes only shown coloured black and marked X on the supplemental map bearing the number of the registration at CL124 Rights Section Entry No. 1 excepting out of the land so shown all those parcels in column 5 of the CL97/124 Entry No 5 and there said to be in the ownership of the Council".

9. I CONFIRM the registration at CL97/124 Entry No. 8 (formerly CL124 No. 2: Lewis Griffiths Jones; Tyddyn-y-Berth) with the MODIFICATION: that for all in column 4 substitute:-

"The right to graze during the months of winter (meaning from 1 November to 30 April in each year) 24 sheep and during the months of summer (meaning from 1 May to 31 October in each year) 6 cattle over the land comprised in this CL97/124 register unit except OS No. 3430 as in this Rights Section defined".

10. I CONFIRM the registration at CL97/124 Entry No. 9 (formerly CL124 No. 3: Evan Edfryn Davies; Erwpistyll) with the MODIFICATION: for all in column 4 substitute:-

"The right to graze during the months of winter (meaning from 1 November to 30 April in each year) 16 sheep and during the months of summer (meaning from 1 May to 31 October in each year) 4 cattle over the land comprised in this CL97/124 register unit except OS No. 3430 as in this Rights Section defined".

11. I CONFIRM the registration at CL97/124 Entry No. 11 (formerly CL124 No. 5: Thomas Alun Jones, Erw) with the MODIFICATION: for all in column 4 substitute:-

"The right to graze during the months of winter (meaning from 1 November to 30 April in each year) 12 sheep and during the months of summer (meaning from 1 May to 31 October each year) 3 cattle over the land comprised in this CL97/124 register unit except OS No. 3430 as in this Rights Section defined".



12. I CONFIRM the registration at CL97/124 Entry No. 12 (formerly CL124 No. 6: Thomas David Jones, Thomas Alun Jones, David Henry Jones; Crychnant) with the MODIFICATIONS for all in column 4 substitute:-

"(1) The right attached to the land particularised at (1) in column 5 to graze during the months of winter (meaning from 1 November to 30 April in each year) 28 sheep and during the months of summer (meaning from 1 May to 31 October in each year) 7 cattle the land comprised in this CL97/124 register unit except OS 3430 as in this Rights Section defined.

(2) The right attached to the land particularised at (2) in column 5, to graze during the months of winter (meaning from 1 November to 30 April in each year) 12 sheep and during the months of summer (meaning from 1 May to 31 October in each year) 3 cattle over the land comprised in this CL97/124 register unit except OS 3430 as in this Rights Section defined".

And in column 5 adding at the end:-

"So that (1) will be all the said farm and land except the OS Nos next hereinafter specified and so that (2) will be the following OS Nos, 2796, 2823, 2824, 2838, 3399, 3384A, 3400, 3404, 3405 and 3415 being some of the land so edged green".

13. To give effect to the confirmations in this Part of this Schedule, the following additional Entry shall be made in the CL97/124 Rights Section:-

"In this Rights Section: "OS 3430" means the part of the land so numbered on the OS map 1/2500 1901 edition and thereon marked as containing 7.764 acres which is comprised in this CL97/124 register unit; and "2653 Area" means the part of the land so numbered on the said map and thereon marked as containing 11.383 acres which is not within the land comprised in the Land Section of Register Unit No. CL97 as such registration was constituted on 4 October 1968".

14. Note: all the above CL97/124 Rights Section registrations will also be subject to the modifications necessarily consequential on the removal from the Register of the Areas specified in paragraph 3 of Part I of this Schedule.
