



COMMONS REGISTRATION ACT 1965

Reference No.219/U/35

In the Matter of Butts Green,  
Lower Hardres, Kent.

DECISION

This reference relates to the question of the ownership of land known as Butts Green, Lower Hardres, being the land comprised in the Land Section of Register Unit No.VG 111 in the Register of Town or Village Greens maintained by the former Kent County Council of which no person is registered under section 4 of the Commons Registration Act 1965 as the owner.

Following upon the public notice of this reference no person claimed to be the freehold owner of the land in question and no one claimed to have information as to its ownership.

I held a hearing for the purpose of inquiring into the question of the ownership of the land at Canterbury on 29th July 1975.

There was no appearance at the hearing.

In the absence of any evidence I am not satisfied that any person is the owner of the land, and I shall accordingly direct the Kent County Council, as registration authority, to register the Lower Hardres Parish Council as the owner of the land under section 8(3) of the Act of 1965.

I am required by regulation 30(1) of the Commons Commissioners Regulations 1971 to explain that a person aggrieved by this decision as being erroneous in point of law may, within 6 weeks from the date on which notice of the decision is sent to him, require me to state a case for the decision of the High Court.

COMMONS REGISTRATION ACT 1965

In the Matter of Chislet Village Green,  
Chislet, Kent.

DECISION

This reference relates to the question of the ownership of land known as Chislet Village Green, Chislet, being the land comprised in the Land Section of Register Unit No.VG 117 in the Register of Town or Village Greens maintained by the former Kent County Council of which no person is registered under section 4 of the Commons Registration Act 1965 as the owner.

Following upon the public notice of this reference Mr J.F.Pettit claimed to be the freehold owner of the land in question and no other person claimed to have information as to its ownership.

I held a hearing for the purpose of inquiring into the question of the ownership of the land at Canterbury on 29th July 1975:

Mrs A.Wilks, the applicant for the registration, appeared at the hearing and informed me that she had no evidence as to the ownership of the land in question.

In the absence of any evidence I am not satisfied that any person is the owner of the land, and I shall accordingly direct the Kent County Council, as registration authority, to register the Chislet Parish Council as the owner of the land under section 8(3) of the Act of 1965.

I am required by regulation 30(1) of the Commons Commissioners Regulations 1971 to explain that a person aggrieved by this decision as being erroneous in point of law may, within 6 weeks from the date on which notice of the decision is sent to him, require me to state a case for the decision of the High Court.
