In the Matter of Staingill, Hartlington Moor Lane, Hartlington, Craven D.

## DECISION.

This reference relates to the question of the ownership of land known as Staingill, Hartlington Moor Lane, Hartlington, Craven D. being the land comprised in the Land Section of Register Unit No. VG.98 in the Register of Town or Village Greens maintained by the former West Riding of Yorkshire County Council of which no person is registered under section 4 of the Commons Registration Act 1965 as the owner.

Following upon the public notice of this reference Hartlington Parish Meeting claimed to be the freehold owner of the land in question and no other person claimed to have information as to its ownership.

I held a hearing for the purpose of inquiring into the question of the ownership of the land at Skipton on 22nd July 1975.

Mr. D.G. Aynsworth, Chairman of the Parish Meeting appeared. He said the parishioners claimed the right to take stone from this land and that the Parish had taken stone from the land for the purpose of repairing the highway to which it is adjacent; the Highway Authority paying for the repair. He had no evidence as to the ownership of the land.

There can clearly be no recreational use for this land which should not have been registered as a village green.

In the absence of any evidence I am not satisfied that any person is the owner of the land, and I shall accordingly direct the North Yorkshire County Council, as registration authority, to register Craven District Council as the owner of the land under section 8(3) of the Act of 1965.

I am required by regulation 30(1) of the Commons Commissioners Regulations 1971 to explain that a person aggrieved by this decision as being erroneous in point of law may, within 6 weeks from the date on which notice of the decision is sent to him, require me to state a case for the decision of the High Court.
