

COMMONS REGISTRATION ACT 1965

Reference No.229/U/39

In the Matter of Village Green Chilson West Oxfordshire D.

DECISION

This reference relates to the question of the ownership of land known as Village Green, Chilson West Oxfordshire D. being the land comprised in the Land Section of Register Unit No.VG.97 in the Register of Town or Village Greens maintained by the Oxfordshire County Council of which no person is registered under section 4 of the Commons Registration Act 1965 as the owner.

Following upon the public notice of this reference no person claimed to be the freehold owner of the land in question and no one claimed to have information as to its ownership.

I held a hearing for the purpose of inquiring into the question of the ownership of the land at Oxford on 12th June 1975.

There was no appearance at the hearing.

In the absence of any evidence I am not satisfied that any person is the owner of the land and I shall accordingly direct the Oxfordshire County Council as registration authority, to register West Oxfordshire District Council as the owner of the land under section 8 (3) of the Act of 1965.

I am required by regulation 30 (1) of the Commons Commissioners Regulations 1971 to explain that a person aggrieved by this decision as being erroneous in point of law may, within 6 weeks from the date on which notice of the decision is sent to him, require me to state a case for the decision of the High Court.

COMMONS REGISTRATION ACT 1965

Reference No. 229/U/40

In the Matter of Part of Village Green and Pond Clanfield, West Oxfordshire D.

DECISION.

This reference relates to the question of the ownership of the land known as part of village green and pond, Clanfield, West Oxfordshire D being the land comprised in the Land Section of Register Unit No. VG.83 in the Register of Town or Village Greens maintained by the Oxfordshire County Council of which no person is registered under section 4 of the Commons Registration Act 1965 as the owner.

Following upon the public notice of this reference no person claimed to be the freehold owner of the land in question and no one claimed to have information as to its ownership.

I held a hearing for the purpose of inquiring into the question of the ownership of the land at Oxford on 12th June 1975. There was no appearance at the hearing.

In the absence of any evidence I am not satisfied that any person is the owner of the land, and accordingly I shall direct the Oxfordshire County ouncil, as registration authority, to register Clanfield Parish Council as the owner of the land under section 8(3) of the Act of 1965.

I am required by regulation 30(1) of the Commons Commissioners Regulations 1971 to explain that a person aggrieved by this decision as being erroneous in point of law may, within 5 weeks from the date on which notice of the decision is sent to him, require me to state a case for the decision of the gigh Court.
