



In the Matter of a Tract of Land forming the
part of the Eppynt in the Parishes of Merthyr Cynog
and Crickadarn

DECISION

This dispute relates to the registration at Entry No. 1 in the Land Section and sundry Entries in the Rights Section of Register Unit No. CL.51 in the Register of Common Land maintained by the Powys County Council and is occasioned by Objections noted in the Register.

I held a hearing for the purpose of inquiring into the dispute at Brecon on 14 March 1983. The hearing was attended by Mr E Masterman of Counsel instructed by Messrs. Jeffreys and Powell, Solicitors of Brecon appearing for the following applicants in the Rights Section. Mr I W Powell (4) Mr and Mrs M T Griffiths (5) Mr and Mrs A J Harley (7) Mr W P Davies (14) Messrs. E L, A D & E Morgan (17) Mr G H Morgan (18) Mr Roddick for the Forestry Commission, Mr Van Hees of Messrs Sydney G Thomas Solicitors of Builth Wells appeared for Mr A T Jones an Objector Mr D E K Richards of Messrs. W J Rees Richards & Partners Chartered Surveyors of Swansea appeared for the Trustees of the Brecon Estates and Mr E T R Jones (Secretary) appeared for the Eppynt Commoners Association.

In a flourish of correspondence between the parties or their representatives all the numerous objections were withdrawn either on terms or unconditionally and the applications at Entry Nos ¹⁰ 16, 17 and 20 were withdrawn.

For these reasons (I) I confirm the following registrations in the Rights Section without modification.

(a) Rights not exercisable over that part of the common situate in the parish of Merthyr Cynog

(b) Rights exercisable only in that part of the common lying in the parish of Gwnnddwr.

(c) 46 limited to 150 sheep or equivalent 7 sheep equalling 1 pony

(d) Rights exercisable only in that part of register unit situated in parish of Crickadarn.

(e) Rights not exercisable in parish of Crickardarn.
