



COMMONS REGISTRATION ACT 1965

Reference No. 276/D/411-414

In the Matter of land called Mynydd-
y-Gribin, Llanllugan

DECISION

These disputes relate to (1) the registrations at Entry No. 1 in the Land Section and Entries Nos. 1 to 5 in the Rights Section of Register Unit No. CL 54 in the Register of Common Land maintained by the Powys County Council and are occasioned by Objection No. 43 made by David H Benbow and noted in the Register on 6 October 1970, (2) the conflicting registrations at Entry No. 1 and Entry No. 2 in the Ownership Section of the Register Unit.

I held a hearing for the purpose of inquiring into the disputes at Welshpool on 10 December 1980. The hearing was attended by Mr E B Roberts, Solicitor, appearing on behalf of Mr Benbow and of three of the applicants for registration in the Rights Section; and by Mr G I William, Solicitor, appearing on behalf of Sir Owen W W Wynn.

Mr Benbow's Objection was withdrawn. The dispute as to ownership arises from the conflicting registrations in the Ownership Section by Sir Owen W W Wynn (No. 1) and Mr Benbow (No. 2), each of whom applied for registration as owner of the land. Sir Owen W W Wynn's claim was now withdrawn.

In these circumstances I confirm the registrations in the Land Section and the Rights Section. As regards the Ownership Section I confirm the registration at Entry No. 2 and refuse to confirm that at Entry No. 1.

I am required by regulation 30(1) of the Commons Commissioners Regulations 1971 to explain that a person aggrieved by this decision as being erroneous in point of law may, within 6 weeks from the date on which notice of the decision is sent to him, require me to state a case for the decision of the High Court.

DECISION

This dispute relates to the registrations at Entry No. 1 and Entry No. 2 in the Ownership Section of Register Unit No. CL 84 in the Register of Common Land maintained by the Powys County Council and is occasioned by the conflict between the two registrations.

I held a hearing for the purpose of inquiring into the dispute at Welshpool on 10 December 1980. The hearing was attended by Mr J I Williams of the firm of Longueville and Company, Solicitors, appearing on behalf of Sir Owen W W Wynn, the applicant for registration at Entry No.1: and by Mr J Hollis of the firm of Milwyn Jenkins and Jenkins, Solicitors, appearing on behalf of Mr T B L Jerman, the applicant for registration at Entry No. 2.

The claim to ownership by Sir Owen W W Wynn was withdrawn and accordingly I refuse to confirm the registration at Entry No. 1 and confirm the registration at Entry No. 2.
